

ADVERTISEMENT FOR BIDS

Separate sealed bids for FURNISHING AND INSTALLING GUARDRAIL, GEISINGER ROAD, RIC-TR426-1.53 FRANKLIN TOWNSHIP, RICHLAND COUNTY, OHIO will be received by the Richland County Board of Commissioners, County Administration Building, 50 Park Avenue East, Mansfield, Ohio 44902 UNTIL 10:15 AM LOCAL TIME MARCH 11, 2010 and then at said office publicly opened and read aloud.

Plans and bid documents shall be obtained at Richland Blue Print, Inc., 121 North Adams Street, Mansfield, Ohio 44902 (Telephone Number 419-524-2781). The bidder must obtain the plans, specifications, etc. at their own expense and the cost is non-refundable. The plans and specifications may be obtained after FEBRUARY 23, 2010.

- A. Each bidder requesting that a set of plans, specifications, etc. be mailed to the bidder shall pay the additional shipping and handling charges to Richland Blue Print, Inc.
- B. The list of those firms or persons obtaining plans and bid documents will be reported at Richland Blue Print, Inc.
- C. No proposals will be entertained unless submitted on forms furnished by Richland Blue Print, Inc.

Each proposal must contain the full name of the party or parties making the same and all persons interested therein, and must be accompanied, pursuant to Section 153.54 of the Ohio Revised Code, by a satisfactory BID GUARANTY AND CONTRACT BOND or PROPOSAL BOND executed by the bidder and an acceptable surety, in an amount equal to one hundred percent (100%) of the total amount for each individual proposal; or by a certified check, cashiers check, or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in an amount equal to ten percent (10%) of the total amount for each individual proposal, payable to Richland County Board of Commissioners as a guarantee that if the proposal is accepted, a contract will be entered into.

SPECIAL CONDITIONS – It is anticipated that the Richland County Road Superintendent will be ready for conduit, cut-off walls and wingwalls to be placed on or about JUNE 1, 2010.

The Owner reserves the right to waive any informalities or to reject any or all bids. All bids shall be approved by Ohio Public Works Commission (OPWC) and no contract shall be awarded without OPWC approval.

Each bidder must have the appropriate, current ODOT prequalification for this type of project, and present their Certificate of Qualification at the time of the bid opening.
